ORDER:-

In the reference 1st read above, the Commissioner of Tribal Welfare, Telangana State, Hyderabad has submitted the proposal and requested the Government to release RS.677.42 lakhs (i.e Rs.250.00 lakhs of 2014-15 + Rs.427.42 lakhs of 2015-16) so as to release the same to the concerned implementing agencies under the Vanabandhu Kalyan Yojana.
